PACT ACT

The PACT Act is a new law that expands VA health care and benefits for Veteran's exposed to burn pits and other toxic substances.

The PACT will bring these changes:

- -Expands and extends eligibility for VA Health care for Veterans with toxic exposures and Veterans of the Vietnam, Gulf War and post-911 eras.
- -Adds more than 20 new presumptive conditions for burn pits and other toxic exposures.
- -Adds more presumptive exposure locations for Agent Orange and radiation.

A presumptive condition for toxic exposure must connected to your military service.

These cancers are now presumptive:

- Brain cancer
- Gastrointestinal cancer of any type
- Glioblastoma
- Head cancer of any type
- Kidney cancer
- Lymphatic cancer of any type

- Lymphoma of any type
- Melanoma
- Neck cancer
- Pancreatic cancer
- Reproductive cancer of any type
- Respiratory (breathing-related) cancer of any type

These illnesses are now presumptive:

- Asthma that was diagnosed after service
- Chronic bronchitis
- Chronic obstructive pulmonary disease (COPD)
- Chronic rhinitis
- Chronic sinusitis
- Constrictive bronchiolitis or obliterative bronchiolitis
- Emphysema
- Granulomatous disease
- Interstitial lung disease (ILD)
- Pleuritis
- Pulmonary fibrosis
- Sarcoidosis

Any Veteran who has or had one of the listed cancers at any time during or after separation from military service may be eligible for disability compensation benefits.

Veterans, survivors or dependents who had claims previously denied for any of these respiratory cancers are encouraged to file a supplemental claim for benefits.

Please contact us if you are a Veteran, survivor or dependent who needs to apply for a new claim or applying supplemental claim for assistance.

STATE SPEED ACT SUMMARY

The Governor signed the SPEED Act bill.

Open Burn Pit Registry

 Directs DPH, in consultation with DVS and National Guard, to develop educational materials and an informational pamphlet on the health impacts of open burn pits during overseas deployment and information on the VA's Airborne Hazards and Open Burn Pit

Registry to be distributed to healthcare providers, service members, and veterans. And to contact all members of the Armed Forces, National Guard and veterans to register for the VA Airborne Hazards and Open Burn Pit Registry.

And requires the Adjutant General to request that the periodic health assessment for National Guard members determine whether the member is eligible to participate in the VA's Airborne Hazards and Open Burn Pit Registry and if eligible, the member register for the Registry.

Massachusetts National Guard Family Education Program

Establishes a Massachusetts National Guard Family Education
 Program to allow National Guard members to transfer their unused education benefits under the National Guard Education Assistance Program to dependents.

Slot Machines at Veterans' Organizations Commission

• Creates a commission to study slot machines at veteran organizations.

<u>Founding Anniversaries of U.S. Army, Air Force, Coast Guard, and National Guard</u>

 Requires the Governor to set aside the founding date anniversaries of the U.S. Army, Air Force, Coast Guard, and Massachusetts National Guard.

Medal of Fidelity

 Establishes the Massachusetts Medal of Fidelity to be presented to the next of kin of a service member or veteran who died as a result of service-related post-traumatic stress disorder or a serviceconnected disease, condition or injury related to exposure to harmful toxin, herbicides, agents or materials.

Deborah Samson Memorial Commission

 Establishes a commission to determine a location for a memorial of Deborah Samson, Massachusetts resident who disguised herself as a man in the Continental Army during the American Revolutionary War.

Funeral and Burial Benefits

• Requires funeral directors and their staffs to provide information on burial and funeral benefits for veterans.

Property Tax exemption

Prohibits a city or town from requesting further evidence from a
disabled veteran in subsequent tax years after a veteran has already
received an exemption by the assessor of that town unless the
disability rating determined by the VA is reduced.

NEWBURY AND WEST NEWBURY DESIGNATED AS PURPLE HEART COMMUNITIES

History of the Purple Heart

"All soldiers know that the Purple Heart is given to those who are wounded or killed while fighting in the nation's wars. Most also know that those who are injured or die in terrorist attacks are eligible to receive the decoration, too. What most soldiers, and most Americans, do not realize, however, is that the Purple Heart is a unique military award. First, it is the oldest U.S. military decoration; General George Washington awarded the first purplecolored heart-shaped badges to soldiers who fought in the Continental Army during the American Revolution. Second, until World War II, the Purple Heart was exclusively an Army decoration and, with rare exceptions, only soldiers received it; the Navy and Marine Corps lacked the authority to award it to sea service personnel. Finally, the Purple Heart is the only decoration awarded without regard to any person's favor or approval; any soldier, sailor, airman or marine who sheds blood in defense of the nation is automatically awarded the Purple Heart. Purple Heart Trail

"The purpose of the Purple Heart Trail is to create a symbolic and honorary system of roads, highways, bridges, and other monuments that give tribute to the men and women who have been awarded the Purple Heart medal. The Purple Heart Trail accomplishes this honorary goal by creating a visual reminder to those who use the road system that others have paid a high price for their freedom to travel and live in a free society. Signs placed at various locations annotate those roads and highways where legislation has been passed to designate parts of the national road system as The Purple Heart Trail." – Military Order of the Purple Heart


LOCAL HEREOS
